We provide group counseling sessions for children (grouped by age and gender) and their protective caregivers in English and Spanish. In order to best serve our clients we are housed in four locations throughout Tarrant County. We provided individual counseling services to over 600 victims of trauma. Our group counseling program served over 200 protective caregivers and over 250 children with confirmed cases of child sexual abuse, bringing our total number of adults and children served throughout the year to more than 2,500. The program offers a number of different modalities to serve clients. Our group counseling program, offered September through June, is a 16-week open-ended format

Multidisciplinary Team Coordination (MDT)
The MDT program coordinates the multidisciplinary team in Tarrant County through review of Department of Family and Protective Services intake reports as well as law enforcement offense reports. MDT then works to collaborate with investigative agencies to facilitate services for families involved in allegations of severe child abuse that meets the Alliance for Children's protocols.

Family Advocate Program
The Family Advocate Program provides case management services to children and families affected by allegations of child abuse. In fiscal year 2020, more than 1,300 families received our family advocacy services. Family advocates helped families stabilize in many ways, such as guiding them through the complex and sometimes confusing investigative and court systems, providing short term financial assistance, assisting families in accessing community resources, referring families to appropriate counseling services and other key services that support families through the trauma of abuse. Our family advocate program also provided specialized healing services.
