Summary:

Clinical Supervisor is responsible for all daily clinical operations at her/his designated center, including but not limited to intakes and individual/group therapy. In addition she/he will provide supervision and support for staff, interns and volunteers.

Job Duties/Essential Functions:

- Provide regular supervision with staff and interns at designated center.
- Provide training to new employees and interns as needed.
- Provide annual training to contract group therapists.
- Provide routine audits on staff documentation and client files.
- Provide individual counseling to 5-7 clients at designated center.
- Provide timely documentation within 48 hours of seeing client.
- Assist Director of Clinical Services in the ongoing development of the Clinical Program.
- Assist Director of Clinical Services with ongoing recruitment of contract therapists.
- Supervise student interns on an as needed basis.
- Lead or sub for groups on an as needed basis.
- Other job duties as requested by immediate supervisor or Chief Executive Officer.

Knowledge/Skills/Abilities:

- Master's degree required in Social Work, Counseling or related field.
- LPC, LCSW, or related certification required.
- A minimum of two years demonstrated relevant work experience including supervisory experience preferred.
- Trained in TF-CBT preferred and knowledgeable of other EBP's.
- Strong communication and documentation skills.

- A minimum of two years of experience working with child abuse victims in a clinical setting preferred.
- Must have valid driver's license and proof of liability insurance if driving for agency purposes.
- Must successfully complete annual criminal and civil background checks.
- Able to maintain confidentiality and present in a positive, professional manner at all times.
- Able to maintain composure and professionalism under pressure of deadlines.
- Regular and reliable attendance.
- Personal qualities of integrity, credibility, and dedication to the mission of Alliance For Children.

Physical Requirements:

Able to grasp, push, pull objects such as files, file cabinet drawers and reach overhead. Able to operate a telephone and computer. Able to lift up to 20 lbs. (usually office supply boxes). Moderate independent travel by private auto required.
